

SUMMARY ANNUAL REPORT

This is a summary of the annual report of the DEALER TIRE LLC WELFARE AND BENEFITS PLAN, EIN 34-1940366, Plan No. 501, for period 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

DEALER TIRE, LLC has committed itself to pay certain self-insured Medical, Short-term Disability, and Wellness claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with VISION SERVICE PLAN and METROPOLITAN LIFE INSURANCE COMPANY to pay Dental, Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Critical Illness, and Hospital claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$5,777,886.
